10. Stability and reactivity

The product is stable in normal conditions of use and storage. Due to thermal decomposition or in the event of a fire vapours may be produced potentially dangerous to health.

11. Toxicological information

Acute effects: stinging eyes. Symptoms may include rubescence, edema, pain and lachrymation. Contact with skin may cause irritation, erythema, edema, dryness and chapped skin. Vapour inhalation may slightly irritate the upper respiratory tract. Ingestion may cause health disorders, including stomach pain and sting, nausea and sickness.

Upon contact with skin, this product causes sensitization (dermatitis). Dermatitis derives from skin irritation on the areas which repeatedly come into contact with the sensitizing agent. 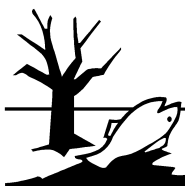
