3.1 Substance/Preparation Classification

3.2 Danger Identification

Because of its chemical-physical features, this product is graded as flammable (flash-point 21 °C or h igher and 55 °C or lower). HARMFUL BY INHALATION AND IN CONTACT WITH SKIN. IRRITATING TO SKIN. RISK OF SERIOUS DAMAGE TO EYES.

4. First-aid measures

EYES: Irrigate copiously with clean, fresh water for at least 15 minutes. Seek medical advice.

SKIN: Wash immediately with plenty of water. Remove contaminated clothing. If irritation persists seek medical attention. Wash contaminated clothing before using them.

INHALATION: Remove to fresh air. If breathing is irregular seek medical advice.

INGESTION: Obtain immediate medical attention. Induce vomiting only if indicated by the doctor. Never give anything by mouth to an unconscious person.

5. Fire-fighting measures

10. Stability and reactivity

The product is stable in normal conditions of use and storage. When heated or in the event of a fire, carbonoxides may be released and vapours which are dangerous to health. The vapours may also form explosive mixtures with the air.

Ethylbenzene: it reacts violently with strong oxidizing agents and attacks different types of plastic material. It is readily biodegradable in water.

Butyl alcohol is biodegradable (MITI1984). The mixture reacts with strong oxidizing agents and with alkaline metals releasing flammable hydrogen. It attacks different types of plastic materials.

11. Toxicological information

Acute effects: inhalation or skin absorption of this product are harmful. This product may irritate mucosa, the upper respiratory tract, and eyes. Exposure symptoms may include: stinging and irritated eyes, mouth, nose, throat; cough, respiratory disorders, dizziness, headache, nausea and sickness.

In the most serious cases, inhalation of this product may cause larynx and bronchial tube edema and irritation, chemical pneumonia and pulmonary edema. Upon contact with skin, this product may irritate it, causing an increase in skin temperature, swelling and itchiness. Ingestion of even small amounts of this product may cause health problems (stomach pain, nausea, sickness, diarrhoea, etc.).

This product may cause serious ocular lesions, cornea opacity, iris lesions, irreversible eye coloration.

Ethylbenzene, like the benzene homologues, may exert an effect on the CNS with depression, narcosis often preceded by dizziness and accompanied by headache (Ispesl). It is irritating to the skin, conjunctivae and respiratory apparatus.

12. Ecological information
